150.2024 Town Hall Repairs

Members considered an update regarding the required repairs to the Town Hall. The surveyor contacted by staff through RCIS had provided advice to prop up the Town Hall from the ground level to the top of the building. He has obtained one quote from a reputable builder. He will be providing a Spec (this would carry some cost) to be sent to other companies. The Council requested that three quotes be provided and that local companies are approached.

RESOLVED to proceed with the surveyor's spec and to get three quotes. An Extra-Ordinary meeting of the Council should consider the quotes.

It was noted that there been discussions with Burgess Lands Trust, it is likely they may agree to cover costs of the first phase of works as discussed above.
